Cookies and other techniques

In addition, you can also delete any information previously stored via your browser settings. Salacia Solutions does not use automated decision-making, including profiling. In addition, we also use a program to track website statistics whereby every visitor remains anonymous.

Editing or removing your personal data

This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks. Salacia Solutions would also like to point out that you have the possibility to file a complaint with the national regulator, the Authority for Personal Data.
